The CTE Committee Public Meeting convened virtually on Zoom. Chair Myra Norton called the meeting to order at 9:00 a.m.

## **WELCOME & PURPOSE**

Chair Myra Norton opened the December 03, 2025 meeting of the CTE Committee by welcoming members and attendees. Chair Norton explained the goals for the Committee meeting.

A quorum was confirmed. The December 03, 2025 Agenda was approved. The November 20, 2025 Meeting Minutes were approved.

## **JOINT VISION STATEMENT**

Chair Norton introduced the CTE Joint Vision Statement, which was created in collaboration with the Maryland State Department of Education (MSDE), the Accountability and Implementation Board (AIB), the Maryland State Board of Education, the CTE Committee, and the Maryland Department of Labor (MD Labor). Chair Norton explained the context and purpose for the CTE Joint Vision Statement.

Executive Director Parker emphasized the importance of how the CTE Joint Vision Statement provides specific guidance and updates on the 45% goal. The CTE Joint Vision Statement revised the 45% goal from “45% of graduating students in the 2030-2031 SY” to “45% of graduating students who are college and career ready in the 2030-2031 SY” to complete the high school level of a Registered Apprenticeship or another industry-recognized credential. The CTE Joint Vision Statement set a specific goal that 1 in 4 students who are college and career ready categorized into the 45% goal will have completed a high school level of a Registered Apprenticeship by the end of the 2030-2031 school year (SY).

Executive Director Parker opened the floor for questions.

Superintendent Wright, Secretary Wu, Member Cavey, and Member Thomas provided words of support for the CTE Joint Vision Statement.

Chair Norton transitioned the Committee to put in a motion to approve the CTE Joint Vision Statement.

Charnetia Young-Callaham provided the motion to approve the CTE Joint Vision Statement. Member Cavey seconded the motion. The CTE Committee unanimously voted to approve the CTE Joint Vision Statement.

## **ADJOURNMENT**

Chair Norton outlined next steps for the Committee: prepare for the January 22, 2025 CTE Committee Meeting.

A motion to adjourn was made and seconded. The meeting was adjourned.
